The tenant agrees not to hold PBL responsible for any loss, damage or legal liability whether the boat is being parked or hauled or moved by PBL employee(s). The tenant agrees that he/she will keep the boat fully insured, indemnity and/or liability insurance for the duration of the season. PBL is not required to carry any insurance to cover the property of the tenant.

## 2019 Pickerel Bay Lodge Boat Docking Rules

**COST:** Tenant agrees to pay the sum of \$540.00+HST for the 2019 Boat Slip Rental. A \$100 non-refundable deposit must be paid by October 6th, 2018 in order to hold the boat slip. Slip fee balances are due May 1st, 2019.

**SEASON:** The Summer Dockage Season is from May 1st to October 14th, 2019. All slip spaces must be vacated on or before October 14th of 2019. Any boats remaining in the slip after October 14th may be subject to additional fees.

**GARBAGE:** All garbage must be put into the appropriate containers. Full bags of trash produced from campsites or cottages and will be subject to garbage fees if disposed of at Pickerel Bay.

**ALCOHOL:** No visible or open alcohol while on PBL property.

**PETS:** All pets must be leashed at all times and picked up after.

**PARKING:** Each boat slip includes parking for one vehicle. Charges apply to additional parking spots. Parking is available for boat trailers. Please inquire at the office for the specified location.

**SLIP CONDITION:** All lines and bumpers for the slip space shall be provided by the tenant at his/her expense. Boat slips will be provided- as is and the tenant will return slip to the original condition prior to vacating it.

**USAGE:** It is understood that the slip space is rented solely for the use of the above described tenant and no other boat or owner may sublease or use slip space without permission of PBL. PBL reserves the right to utilize Tenant's Slip any time when vacant. PBL reserves the right to move Tenant's boat or watercraft at any time, to protect the property of PBL or the safety of other slip owners or the public. PBL reserves the right to assign or re-assign Tenant's slip location at any time.
